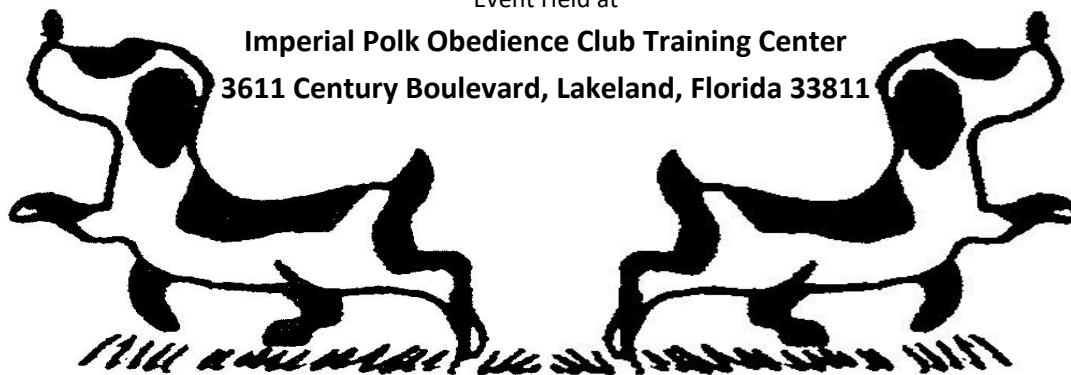

Block of 8 runs Day (same dog): \$175  
Block of 16 runs Weekend (same dog): \$340

**ALL ENTRIES MUST BE LEGIBLE AND FILLED OUT COMPLETELY AND INCLUDE DOG'S CURRENT UKC REGISTRATION NUMBER – PLEASE CHECK THE VALIDITY OF ANY TEMPORARY REGISTRATION NUMBERS PRIOR TO SUBMISSION**

IPOC will charge a \$25.00 fee for a returned check.

Females in season are **NOT** allowed to compete. If a female is withdrawn from competition because she came into season and the event secretary is notified in writing (written, email or text message) no later than one-half hour prior to the start of the first class in the trial, the entry fee will be refunded, less a processing fee.

ENTRIES ARE LIMITED and will be taken on a first come first served basis, (so get your entries in early). Crating Area is limited, X-pens, Pet Playpens or tents will not be allowed at the trial site. Fire aisles **MUST** always be kept clear. No unentered dogs are permitted or allowed at the site.

Dogs should be present at least one-half hour before they are to be judged. The owner or handler is solely responsible for having their dog at the designated staged waiting area when it is due on the line. Dogs not required for further judging may be excused.
