From I-4: Take Exit 27 (Polk County Parkway - Highway 570) to the first exit (Airport Road), approximately three miles. Turn right onto Airport Road, go to the second light (Drane Field Road), and turn left. Then, stay on Drane Field Road to Century Boulevard, which will be the first street on the left after the round-about circle (across from the firehouse station). Turn into the industrial complex, then use the third driveway on the left. The IPOC building is straight ahead.

From Highway 60: Take Highway 60 to S. County Line Road. Go approximately five miles, turn right onto Drane Field Road. Stay on Drane Field Road for approximately three miles to Century Boulevard, which will be the first street on the left after the round-about circle (across from the firehouse station). Turn into the industrial complex, then use the third driveway on the left. The IPOC building is straight ahead.
