**UDX Class:**

When entries are limited in the Open and/or Utility classes, a club must designate a UDX class in the premium list. Dogs entered in this class would be entered in both Open B and Utility B, and the combined entry fee for these two classes must be paid. Once the limit has been reached in either the Open or the Utility class, the UDX class will be considered closed and any subsequent entries for this class will be rejected.

**PUTD Class:**

When entries are limited in the Preferred Open and/or Preferred Utility classes, a club must designate a PUTD class in the premium list. Dogs entered in this class would be entered in both Preferred Open and Preferred Utility, and the combined entry fee for these two classes must be paid. Once the limit has been reached in either the Preferred Open or the Preferred Utility class, the PUTD class will be considered closed and any subsequent entries for this class will be rejected.



If a female is withdrawn from competition because she came into season and the event secretary is notified in writing (written, email or text message) no later than one-half hour prior to the start of the first class in the trial, the entry fee will be refunded less a processing fee of \$5.00 per entered class.


ENTRIES ARE LIMITED and will be taken on a first come first served basis, (so get your entries in early). The crating Area is limited. X-pens, Pet Playpens or Pet Tents will not be allowed at the trial site. Fire aisles **MUST** always be kept clear. No unentered dogs are permitted or allowed at the site. **IPOC will charge a \$25.00 fee for a returned check.**

Dogs should be present at least one-half hour before they are to be judged. The owner or handler is solely responsible for having their dog at ringside when it is due in the ring. Dogs not required for further judging may be excused.

A two-day Trial Catalog will be available for \$5.00 on the day of the trial. Electronic correspondence will be used to send your entry information and judging program. Please supply your correct email address. If you require a hard copy to be sent to your USPS mail address, please check the box on your entry form to say that.

## Directions to the Trial Site

**From I-4:** Take Exit 27 (Polk Parkway – Highway 570) to the first exit (Airport Road) approximately three miles. Turn right onto Airport Road, go to the second light (Drane Field Road), and turn left. Then stay on Drane Field Road to Century Boulevard, which will be the first street (on the left) after the circle (across from the firehouse station). Turn into the industrial complex, then use the third driveway on the left. The IPOC building is straight ahead.



**From Highway 60:** Take Highway 60 to S. County Line Road. Go approximately five miles, turn right on Drane Field Road. Stay on Drane Field Road for approximately 3 miles to Century Boulevard, which will be the first street on the left after the traffic circle (across from the fire station). Turn into the industrial complex, then use the third driveway on the left. The IPOC building is straight ahead.
