After completion of the above requirements of 3 meetings and 3 events, Membership Applications will be voted on during general Membership Meetings. Once approved for Active Membership status, you will be entitled to reduced prices for training classes or other events.

**\*Explanation of Yearly Dues:** Our club's fiscal year runs from June through May. After being voted in as an Active Member, you must pay the club dues (this is in addition to the application fee). If your Membership is approved during the months of June through December, yearly dues are \$55 for 1 Adult or \$85 for a Couple. If approved during the months of January through May, one-half of the yearly dues are \$27.50 for 1 Adult or \$42.50 for a Couple.
